### **54<sup>th</sup> Synod of the Diocese of Tasmania**

Representatives from all over the Diocese met over two days at Launceston Grammar this June in the First Session of the 54<sup>th</sup> Synod of the Diocese of Tasmania. It was a very full program considering matters of importance in our shared life in the Diocese and in the wider Anglican Church and Anglican Communion.

Below are some of the highlights and key matters that we were able to consider

#### **Diocesan Vision – progress report**

Bishop Richard spent a large proportion of his Presidential Address looking at the progress being made across the Diocese on the Diocesan Vision. Progress on a number of measures has been tracked, including:

- Parishes with identified pathways to engage with people, share the good news of Jesus with them, establish them in the faith, and equip them for ministry,
- Parishes with ministries to young people and their families,
- Parishes with transformative public worship; and
- A culture of safety in our churches.

The Bishop noted that the trends are extremely encouraging – a steady *increase* in the number of parishes that have achieved or started work on key objectives in the Vision, and a *decrease* in the number of parishes that are yet to commence. #### **Anglican Communion – impaired relationships and new relationships**

A sad fact of the worldwide Anglican Communion is that, over the last 20-30 years some parts of our denomination, especially in the West, have moved away from the scriptural moorings of the Anglican Church, and have revised their doctrine especially as it relates to the human person, marriage and sexuality. The actions in this area of some provinces in North and South America, Europe and now New Zealand, have brought about what the Primates' Council<sup>i</sup> called 'a tear in the fabric of our Communion'.

Two motions were debated and passed by the Synod – the first lamenting the impaired relationships in our communion, brought about by the decisions to reject the authority of the bible on human sexuality and marriage, and to act against the 1998 resolution of the Lambeth Conference which re-endorsed this authority; and the second expressing a desire to be in communion with provinces which are holding faithfully to the authority of scripture.

### **Indigenous Reconciliation**

One highly significant matter that we as a Diocese need to address is the matter of reconciliation with the indigenous peoples of Tasmania. The Bishop reminded us that, during our Lenten season of lament and repentance last year, we asked for forgiveness for our church's historic involvement in the treatment of the indigenous peoples of Tasmania. The Bishop stated that it is time we take a step from the sins of the past towards a reconciled future in our relationships with indigenous Tasmanians.

The Synod considered and passed a motion that we seek to walk with Tasmanian indigenous communities in reconciliation at all levels of the Tasmanian Anglican Church.

### **Parish Administration**

The Synod spent a significant amount of time working through the detail of a series of new Ordinances relating to Parish Administration. These Ordinances will be published on the Diocesan website and will commence from 1 July 2019. The Ordinance just passed has re-ordered the previous Ordinance to make things easier to find but has not made material changes to the way parishes will operate. The Synod has referred further review of parish administration and governance to a working group to be established by the Bishop

### **Burial Grounds**

One highly significant change in the way that parishes administer property relates to burial grounds. The Synod passed an ordinance to facilitate centralised administration and management of burial grounds. The introduction of this will be a staged process and will allow flexibility for parishes depending on their desire and capacity to continue to be involved in managing burial grounds in their area.

### **Elections of new members of boards and committees**

This Synod, being the first session of the three-year Synod cycle, saw the election of a variety of people to positions on the boards and committees that do so much work for the Diocese throughout the year. A list of people elected to those positions is appended to this letter for your information and prayers.
