## **POSITION DESCRIPTION**

Position	Youth/Young Adults Minister
Revised	10 <sup>th</sup> March 2021
Employment Conditions	The position will be at 3 days/week which is .6 FTE, and an initial contract of 2 years will be sought. Whilst a commitment to the youth and young adult's ministry on Sundays is essential the actual days of work and the total hours is subject to negotiation at appointment stage. There will be a 3 month and annual review process.
Remuneration	Stipend and allowances will be based on either the Ministry Worker or Assistant Minister levels as set by the Diocese. The appropriate level will be determined by the successful candidate's qualification and experience
Objective	Our Parish Vision is to be "A Church for Clarence South, Making disciples of Jesus"  The youth and young adults ministry worker will work alongside the Incumbent, Parish Council, ministry staff and parents to grow individuals and teams in leading a discipling culture in all areas of their ministry
Level of Responsibility	The youth and young adults ministry worker will work under the direct supervision and direction of the Incumbent. They will be expected to show high levels of initiative and self-direction on a day-to-day basis, within their areas of responsibility.
Conditions	Successfully complete a pre-employment Safe Ministry Check.  Maintain both SCC accreditation to a minimum standard of Team Leader, and a current Working with Vulnerable People's Card.
Other	The parish will provide office facilities as needed, provide allowance toward personal development, reimburse Ministry expenses (within a budget previously negotiated with your supervisor) and also provide 4 weeks pro rata annual leave (dates by negotiation with your supervisor) and 10 days personal leave (pro rata) per annum
