### **About the Position**

The RHH Chaplaincy Services operates as a multi-faith department within the Allied Health Professional Services of the Tasmanian Health Service, consisting of Chaplains & Pastoral Care Workers from different faith traditions and Christian denominations.

The Mental Health Chaplain is a senior member of the RHH Chaplaincy Service providing Spiritual and Emotional care for patients, visitors and staff in the Mental health inpatients units of the RHH and the Roy Fagan Centre, including Spiritual Care interventions for complex religious and spiritual needs.

Chaplains provide Spiritual Assessments, Spiritual Counselling / Education and Rituals according to the relevant standards and policies of the THS Chaplaincy Service. Chaplains

Chaplains are bound by the standards, code of conduct, policies, protocols and guidelines of the Department of Health and Chaplaincy Service.

### **Focus of Duties**

- Be an active member of the RHH Chaplaincy Team including attendance at team meetings, team development sessions, social and supervision engagements.
- Identifying and responding to the spiritual needs of inpatients, visitors, community and referred patients, families and other service providers (including staff) of the RHH Mental Health In-Patient Units and the Roy Fagan Centre.
- Assist in the training and supervision of CPE and other students, Pastoral visitors, and visiting clergy.
- Present on Mental Health In-patient units and the Roy Fagan Centre and provide In-services and education to THS Staff.
- Refer patients to appropriate faith community contacts / clerics or other support services as required.
- Record keeping as per protocols and administrative duties as required.
- Assist visiting clergy as needed.
- Provide rituals and ceremonies as required including Chapel services, memorial services, funerals and religious services
- Attend family conferences and other team interventions as needed.
- Provide On-Call and after-hours assistance in negotiation with the Coordinator- RHH Chaplaincy Services.
- Obtaining clinical or pastoral supervision and maintain an effective method and measure of self-care.
- Other duties as identified by the Chaplaincy Coordinator in accordance with the capacity, qualifications and experience of the Chaplain.

# **ESSENTIAL REQUIREMENTS**

- A demonstrated understanding of the philosophy of Pastoral Care and mental illness and its impact on consumers, including delusions regarding religion.
- Ability to engage with key pastoral issues of loss, grief, trauma, dementia and other mental health issues within a multifaith context

- Attend at least ten (10) hours of pastoral care per year, from a suitably qualified member of your local parish
